

PROCEEDINGS OF THE BEADLE COUNTY COMMISSION
JANUARY 3, 2023

The Board of Beadle County Commissioners met Tuesday, January 3, 2023, with members present: Chair Doug Ramsell, Vice Chair Rick Benson, Denis Drake, Allen Greenfield, and Dennis Meyer.

Chair Ramsell determined business for 2022 to have been completed and adjourned at 9:04 a.m. – sine die.

Beadle County Auditor Jill Hanson swore in the following Elected Officials: Denis Drake, County Commissioner District #1; Allen Greenfield, County Commissioner District #3, Dennis Meyer, County Commissioner District #5, Doug Solem, Beadle County Sheriff and Judy Rodacker, Register of Deeds.

Auditor Jill Hanson called for nominations for 2023 Chair. Commissioner Drake nominated Commissioner Ramsell.

Moved by Benson, seconded by Greenfield, motion carried to close nominations and instruct the Auditor to cast unanimous vote for Commissioner Ramsell as Chair.

Auditor Jill Hanson called for nominations for 2023 Vice Chair. Commissioner Drake nominated Commissioner Benson.

Moved by Meyer, seconded by Ramsell, motion carried to close nominations and instruct the Auditor to cast unanimous vote for Commissioner Benson as Vice Chair.

Commissioner Ramsell chaired the remainder of the meeting with members present: Chair Doug Ramsell, Vice Chair Rick Benson, Denis Drake, Allen Greenfield, and Dennis Meyer.

At 9:30 a.m. Chair Ramsell declared time for Bid Opening for the bids for Metal Pipe (Culverts) & Bridge materials. The following bids were received:

1. TrueNorth Steel – Huron SD
(Bid in its entirety on file in the Auditor's Office)

Moved by Drake, seconded by Benson, motion carried to accept the bid of TrueNorth Steel as lowest bidder and in the best interest of the County.

The Commissioners set the bid date for prisoner meals for January 31, 2023, at 11:00 a.m.

Moved by Benson, seconded by Drake, motion carried to go into Executive Session for personnel pursuant to SDCL 1-25-2 (1) at 10:00 a.m. Chair Ramsell declared Executive Session over at 10:20 a.m.

Moved by Benson, seconded by Greenfield, motion carried to terminate employment, effecting immediately, of Abraham Millan, Beadle County Community of Health Nurses.

The Board worked on General Policies.

Moved by Greenfield, seconded by Meyer, motion carried to go into Executive Session for personnel pursuant to SDCL 1-25-2 (1) at 11:05 a.m. Chair Ramsell declared Executive Session over at 11:35 a.m.
